of 26 January 2021

**on the announcement of a public competition for the post of
the President of the Institute of National Remembrance -
Commission for the Prosecution of Crimes against the Polish
Nation**

Based on Article. 23 sec. 2 point 8, in connection with Art. 10 sec. 3 of the Act of 18 December 1998 on the Institute of National Remembrance - Commission for the Prosecution of Crimes against the Polish Nation (Journal of Laws of 2019, item 1882 and of 2020, item 1273), the following has been resolved:

§ 1.

The Chapter of the Institute of National Remembrance - Commission

for the Prosecution of Crimes against the Polish Nation, hereinafter referred to as "IPN-KŚZpNP", accepts the content of the announcement of the competition for the post of the President of the Institute of National Remembrance-KŚZpNP as specified in the annex to the Resolution.

§ 2.

1. The Chairman of the Chapter of the Institute of National Remembrance-KŚZpNP shall announce a public competition for the post of the President of the Institute of National Remembrance-KŚZpNP within 7 days of adopting the Resolution.

2. The Chairman of the IPN-KŚZpNP Chapter shall publish the announcement of the competition for the post of the President of the Institute of Remembrance in the Public Information Bulletin of the IPN-KŚZpNP.

§ 3.

The resolution shall come into force on the day of its adoption.
